I. Elections

- a. Discussion. After review of the constitution and with consent of the CRO, those in attendance agreed to hold elections without incumbent board members (CEO, CFO, CIO, & CGO).

- c. Speeches/Q&A. Each candidate gave introduction and explained why they were running. CEO candidates discussed their platform, followed by Q&A
  - i. *Eugene*: Would like to explore other issues such as political activism, affirmative action for Asian Americans and the Filipino community; knowledgeable about PST, its goals, its history and general corporate mind set.
  - ii. *Liezl*: More about management; very organized; there is miscommunication in PST, which causes a lot assumptions; small goals; get the ball rolling-everything currently is in disarray; will pick up the phone and will return calls
